

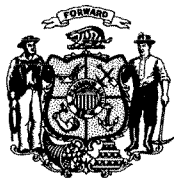

ASSEMBLY AMENDMENT,  
TO 2005 ASSEMBLY BILL 1090

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 4: after that line insert:

3 **"SECTION 1m.** 961.22 (2m) of the statutes, as created by 2005 Wisconsin Act 14,  
4 is repealed and recreated to read:

5 961.22 (2m) PSEUDOEPHEDRINE. Pseudoephedrine or any of its salts, isomers,  
6 or salts of isomers."
