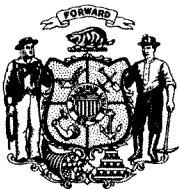

1 AN ACT ...; relating to: a Medical Assistance supplementary rate reimbursement
2 for nursing homes and making an appropriation.

Analysis by the Legislative Reference Bureau

Under current law, the Department of Health and Family Services administers the Medical Assistance (MA) Program, under which persons with low income and few assets receive health care, including nursing home care, that is funded jointly by Wisconsin and the federal government.

This bill modifies a one-time MA nursing home reimbursement supplement for fiscal year 2005-06 contained in 2005 Wisconsin Act (Assembly Bill 981) to clarify that the supplement is to the reimbursement rate under MA for care provided in nursing homes. The bill, enacted as an act, is void unless 2005 Wisconsin Act (Assembly Bill 981) is both enacted before this act and enacted in the form that it passed the assembly.

TO 2005 SENATE BILL (LRB-4522/1)**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 6: after "Program" insert "and Medical Assistance

1 proportionate share of numbers of Medical Assistance recipient patient days in fiscal
2 year 2004-05.

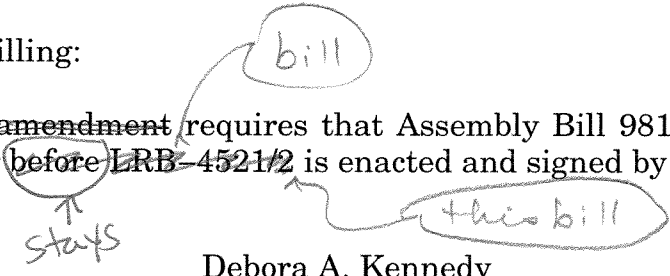
