

8 substitute “political subdivision, ~~either~~”.

9 **5.** Page 6, line 21: delete “~~political subdivision~~ municipality” and substitute  
10 “political subdivision”.

11 **6.** Page 6, line 22: delete the material beginning with that line and ending with  
12 page 7, line 3.
