Under this bill, a taxation district which imposes property taxes is required to remove the name of a property owner, upon the owner's request, from an Internet listing of property taxes assessed by the district. Such an Internet listing may contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction.

The bill also specifically authorizes a taxation district to maintain records in its offices that contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction, and these office records may also contain the name of the property owner.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 66.0145 of the statutes is created to read:

66.0145 Listing of property tax assessments. (1) If a taxation district maintains an Internet listing of property taxes assessed within the jurisdiction and

if that listing contains the name of the property owner against whom the assessment is made, the taxation district shall remove the property owner's name from the Internet listing upon the property owner's request. The Internet listing may contain the amount of property taxes assessed for each parcel number or street address within the jurisdiction.
