Analysis by the Legislative Reference Bureau

Under this bill, a taxation district ^(district) ~~which~~ ^{that} imposes property taxes is required to remove the name of a property owner, upon the owner's request, from an Internet listing of property taxes assessed by the district. Such an Internet listing may contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction.

The bill also specifically authorizes a ~~taxation~~ district to maintain records in its offices that contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction, and these office records may also contain the name of the property owner.

For further information see the *local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Analysis by the Legislative Reference Bureau

Under this bill, a taxation district (district) that imposes property taxes is required to remove the name of a property owner, upon the owner's request, from an Internet listing of property taxes assessed by the district. Such an Internet listing may contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction.

The bill also specifically authorizes a district to maintain records in its offices that contain the property taxes assessed by the district for each parcel number or street address within the jurisdiction, and these office records may also contain the name of the property owner.


