2               Whereas, the 2005–06 University of Wisconsin men's hockey team claimed the  
3       2005–06 NCAA Division I Men's Ice Hockey National Championship with a 2–1 win  
4       over Boston College on Saturday, April 8, 2006; and

5               Whereas, the UW men's hockey team finished its remarkable season with an  
6       impressive 30–10–3 record, was the only team in the nation to reach 30 victories in  
7       the 2005–06 season, and was awarded the number one overall seed in the NCAA  
8       tournament; and

9               Whereas, the UW men's hockey team was recognized with a number of team  
10       and individual achievements, including 3 all-WCHA selections, 5 all-WCHA  
11       academic selections, 3 named all-Americans, and 4 NCAA all-tournament  
12       selections, including Robbie Earl who was named the tournament's most  
13       outstanding player and Brian Elliot who was named WCHA defensive player of the  
14       year and a finalist for the Hobey Baker Award, college hockey's most prestigious
