SECTION 1. Assembly rule 99m is created to read:

If reimbursement of travel expenses for representatives to the assembly is not authorized for attendance at national conferences that are primarily funded from public funds, no representative may attend any conference or other meeting of the American Legislative Exchange Council or any other organization that is primarily funded from funds from special interests.
