This assembly resolution prohibits members of the assembly who have felony charges pending against them from serving as members of the legislative or assembly committees on organization or finance while the felony charges are pending.

4 **Resolved by the assembly, That:**

5 **SECTION 1.** Assembly rule 9 (7m) is created to read:

6 ASSEMBLY RULE 9 (7m) A member who has a felony charge pending against him
7 or her may not become or continue to serve as a member of the assembly committee
8 on organization; the joint committee on legislative organization; or the assembly or
9 joint committee on finance while the felony charge is pending.
