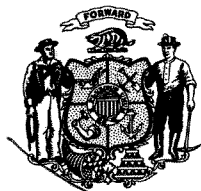

2005 ASSEMBLY RESOLUTION

1 **To amend** assembly rule 39 (4) (c); **relating to:** referral of proposals.

Analysis by the Legislative Reference Bureau

Current assembly rules generally require the speaker to refer a properly jacketed proposal with 14 days after the office of the chief clerk has received the proposal for introduction. This resolution reduces the number of days to 7 days.

2 **Resolved by the assembly, That:**

3 " SECTION ~~14~~^{7M} ← (7M) Assembly rule 39 (4) (c) is amended to read:

4 ASSEMBLY RULE 39 (4) (c) The speaker shall refer a properly jacketed proposal
5 within ~~14~~ 7 working days after the office of the chief clerk receives the proposal for
6 introduction or to be offered or on the final legislative day of the last
7 general-business floorperiod preceding the veto review session, whichever is earlier.
8 The chief clerk shall publish the referral in the first journal published after the
9 referral is made. "
