1 in the messages shall be taken up immediately unless referred by the presiding
2 officer to a standing committee or to the calendar. Any messages from the senate
3 referring to a senate joint resolution memorializing Congress or any branch or officer
4 of the federal government that is received for consideration of the assembly may be
5 read but the senate joint resolution may not be received for consideration.—The,
6 unless the senate joint resolution memorializes Congress or any branch or officer of
7 the federal government to buy American-made goods and encouraging others to do
8 the same. Any senate joint resolution that does not memorialize Congress or any
9 branch or officer of the federal government to buy American-made goods and
10 encouraging others to do the same shall be transmitted to the senate immediately
11 after the message is read;

12 **SECTION 2.** Assembly rule 39 (1) is amended to read:

13 **ASSEMBLY RULE 39 (1)** Except as otherwise provided in joint rule 83 (2) and this
14 subsection, any member or standing committee may introduce or offer proposals in
15 the assembly on any day of the biennial legislative session. No member or standing
16 committee may offer any assembly joint resolution or resolution memorializing
17 Congress or any branch or officer of the federal government, unless the assembly
18 joint resolution or resolution memorializes Congress or any branch or officer of the
19 federal government to buy American-made goods and encouraging others to do the
20 same.
