2 in the messages shall be taken up immediately unless referred by the presiding
3 officer to a standing committee or to the calendar. Any messages from the senate
4 referring to a senate joint resolution memorializing Congress or any branch or officer
5 of the federal government that is received for consideration of the assembly may be
6 read but the senate joint resolution may not be received for consideration.—The,
7 unless the senate joint resolution memorializes Congress or any branch or officer of
8 the federal government (with questions regarding Gulf War syndrome, lung cancer,
9 and combustion illnesses of veterans of the first or second Gulf War) Any senate joint
10 resolution that does not memorialize Congress or any branch or officer of the federal
11 government (with questions regarding Gulf War syndrome, lung cancer, and
12 combustion illnesses of veterans of the first or second Gulf War] shall be transmitted
13 to the senate immediately after the message is read;

14 **SECTION 2.** Assembly rule 39 (1) is amended to read:

15 ASSEMBLY RULE 39 (1) Except as otherwise provided in joint rule 83 (2) and this
16 subsection, any member or standing committee may introduce or offer proposals in
17 the assembly on any day of the biennial legislative session. No member or standing
18 committee may offer any assembly joint resolution or resolution memorializing
19 Congress or any branch or officer of the federal government, unless the assembly
20 joint resolution or resolution memorializes Congress or any branch or officer of the
21 federal government (with questions regarding Gulf War syndrome, lung cancer, and
22 combustion illnesses of veterans of the first or second Gulf War]
