

5 next spring or general election occurring not sooner than 45 days after adoption of
6 this resolution:

7 **QUESTION 1: Health Care in Wisconsin.** ✓ "The health and well-being ✓ of the
8 people having been determined to be fundamental to the enjoyment of the rights of
9 life, liberty, and the pursuit of happiness, should the right of the residents of
10 Wisconsin to adequate, accessible, and affordable health care be ensured by the state
11 as one of its necessary duties that the legislature shall provide for by law?" ✓
