## 2005 SENATE JOINT RESOLUTION

1 **Relating to:** recognizing November 10 as Wisconsin Air Force ROTC Day in the  
2 state of Wisconsin.

3 Whereas, the Reserve Officer Training Corps (ROTC) has had a long history in  
4 Wisconsin dating back to just after the Civil War; and

5 Whereas, ROTC produces over 60 percent of all officers in the United States  
6 Armed Forces; and

7 Whereas, ROTC only accepts the best of the best to become Officers in the Armed  
8 Forces; and

9 Whereas, the Air Force ROTC mission is "To produce leaders for the Air Force  
10 and build better citizens for America"; and

11 Whereas, the Army ROTC mission is "To commission the future officer  
12 leadership of the United States Army"; and

13 Whereas, the Navy ROTC mission, in part, is "To develop midshipmen mentally,  
14 morally, and physically and to imbue them with the highest ideals of duty, honor and  
15 loyalty..."; and

1           Whereas, these missions show the depth of character and the values these  
2 cadets, midshipmen, and officer candidates must possess; and

3           Whereas, Wisconsin is proud to support and defend the right for cadets,  
4 midshipmen, and officer candidates to participate in ROTC at public and private  
5 universities across the state; now, therefore, be it

6           ***Resolved by the senate, the assembly concurring, That*** the legislature of  
7 Wisconsin hereby recognizes November 10, 2005, and subsequent yearly  
8 anniversaries thereafter as "Wisconsin ROTC Day".
