

Effect of the Change

This appropriation will be moved from the Department's Division of Children and Family Services (DCFS) to the Division of Public Health (DPH).

Rationale for the Change

The Department is requesting the transfer of the food distribution program from DCFS to DPH in order to consolidate several food and nutrition programs in the same administrative structure. The appropriation which allows for grants to the food distribution program must be renumbered to reflect the placement of the program.
