<b>PROPOSED CHANGE:</b>	<p><del>23.09(25) Motorcycle recreational program.</del> (a) The department shall administer an off the road Type 1 motorcycle recreational aid program from moneys appropriated under <u>s. 20.370 (5) (cv)</u>. The department shall distribute these funds to towns, villages, cities, counties and federal agencies for the acquisition, development, operation and maintenance of off the road Type 1 motorcycle trails and facilities. The department may distribute these funds before July 1, 1989, to towns, villages, cities, counties and federal agencies for the acquisition, development, operation and maintenance of all terrain vehicle areas and trails if these areas and trails are also available for use by off the road Type 1 motorcycles. In addition, the department may expend moneys appropriated under <u>s. 20.370 (5) (cv)</u> for the development and maintenance of existing off the road Type 1 motorcycle trails at the Black River State Forest and the Bong State Recreation Area.</p> <p><del>23.09(25)(b) The department shall promulgate rules and develop guidelines to administer this subsection.</del></p> <p><b>ross Reference:</b> <i>See also ch. NR 65, Wis. adm. code.</i></p> <p><del>23.09(25)(c) The state or its agencies shall not be liable for any injury to any person or damage to any property in connection with or arising out of the use of any lands acquired, developed or operated under this subsection by a town, village, city or county.</del></p>
