STATUTORY MODIFICATIONS**

TOPIC: Title Fee Increases

DESCRIPTION OF CHANGE:

Original and Transfer Title Fee - Increase the fee for original or first Wisconsin Certificate of Title and for titles issued after an ownership transfer. This change would raise the total certificate of title fee from \$35.00 to \$50.00 for an estimated 1,500,000 transactions and increase revenues by \$22,500,000 annually once the fee increase is fully implemented.

Amend s. 342.14(1) and (3) Wis. Stats., to change the original or transfer title fee from \$18.50 to \$33.50.

This provision is effective three months after the effective date of the bill.

Replacement Title Fee - Increase the fee for a replacement Wisconsin Certificate of Title when customers apply for a replacement or duplicate product when the original certificate has been lost, stolen, or mutilated. Assuming a reduction in the number of documents issued due to the increased price, increasing the fee from \$8.00 to \$40.00 would raise revenues \$2,415,200 annually once the fee increase is fully implemented.

Amend s. 342.14(5) Wis. Stats., to change the replacement title fee from \$8.00 to \$40.00.

This provision is effective three months after the effective date of the bill.

JUSTIFICATION:

The Department requires additional revenue to fund priority transportation programs, including:

- Reconstruction of the Marquette Interchange and rehabilitate the Southeast Wisconsin Freeway System;
- Maintaining program levels in the State Highway Rehabilitation and Majors Programs; and
- Providing transportation aids to local governments.

A low replacement title fee is not indicative of the work involved to produce this product. The work and cost involved in a replacement title are equivalent to producing an original title. As a result of the low title replacement fee, there is little incentive for customers to attempt to locate their lost title document, thus encouraging application for a replacement. A title replacement fee that is similar to the original and transfer title fee would discourage this behavior.
