TO 2005 ASSEMBLY BILL $100 \checkmark$



At the locations indicated, amend the substitute amendment as follows:

1. Page 357, line 19: after that line insert:

"Section 541r. 27.01 (3m) of the statutes is created to read:

27.01 (3m) CLOSURE OF STATE PARKS AND ENTRANCES; HEARING. (a) The department may not close any entrance to a state park without first holding a public hearing in the state park or in the county in which the entrance is located.

(b) The department may not close a state park without first holding a public hearing in the state park or in a county in which the state park, or a portion of the state park, is located.

The department shall publish notice of a hearing required under sub (1) 10

as a class 1 notice under ch. 985. The department may give such further notice as 11

it considers proper, and shall give individual notice to persons specifically requesting notice of any public hearing on the closure. Notwithstanding s. 227.42, the hearing shall be an informational hearing and may not be treated as a contested case hearing or converted to a contested case hearing.".
