TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2005 ASSEMBLY BILL 100**

- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 88, line 4: increase the dollar amount for fiscal year 2005-06 by
3 \$9,000,000 and increase the dollar amount for fiscal year 2006-07 by \$9,000,000 to
4 decrease funding for the purpose for which the appropriation is made.
- 5 **2.** Page 89, line 3: increase the dollar amount for fiscal year 2005-06 by
6 \$9,533,300 and increase the dollar amount for fiscal year 2006-07 by \$19,066,700 to
7 increase funding for the purpose for which the appropriation is made.
- 8 **3.** Page 89, line 5: increase the dollar amount for fiscal year 2005-06 by
9 \$6,000,000 and increase the dollar amount for fiscal year 2006-07 by \$6,000,000 to
10 increase funding for the purpose for which the appropriation is made.

1 **4.** Page 99, line 1: increase the dollar amount for fiscal year 2006–07 by
2 \$11,431,600 to increase the authorized FTE positions for the Board of Regents of the
3 University of Wisconsin System by 120.0 GPR faculty positions.

4 **5.** Page 99, line 1: increase the dollar amount for fiscal year 2005–06 by
5 \$53,500,000 and increase the dollar amount for fiscal year 2006–07 by \$33,500,000
6 to increase the authorized FTE positions for the Board of Regents of the University
7 of Wisconsin System by 200.0 GPR positions in each fiscal year of the biennium.

8 **6.** Page 103, line 3: increase the dollar amount for fiscal year 2005–06 by
9 \$1,500,000 and increase the dollar amount for fiscal year 2006–07 by \$1,500,000 to
10 increase funding for the purposes for which the appropriation is made.

11 **7.** Page 103, line 10: increase the dollar amount for fiscal year 2005–06 by
12 \$393,400 and increase the dollar amount for fiscal year 2006–07 by \$546,200 to
13 increase funding for the purpose for which the appropriation is made.

15 \$482,400 and increase the dollar amount for fiscal year 2006–07 by \$505,600 to

6 amount of the minimum grant. Grants under sub. (1) shall not exceed \$2,500 \$3,000
7 during any one academic year. The board shall, by rule, establish a reporting system
8 to periodically provide student economic data and shall promulgate other rules the
9 board deems necessary to assure uniform administration of the program.”.
