**Suggested amendment to Assembly Substitute Amendment 1
to 2005 AB-100**

At page 1012, line 11, after "System" insert: ", the department of employee trust funds and the state of Wisconsin investment board".

Rationale: The clear purpose of s. 9155 (1w) of ASA 1 is to eliminate state attorney positions and to lapse the money saved into the general fund. However, the salaries and fringe benefits of attorneys employed by DETF and SWIB are paid from the Public Employee Trust Fund. It is not legally permissible to lapse Trust Fund dollars into the general fund, so the legislation should expressly exempt the DETF and SWIB along with the existing exception for the UW System. This amendment also would eliminate any need to bring legal action to protect the Trust Fund and enjoin DOA from taking action against DETF or SWIB positions.
