in 6-29-05

1 At the locations indicated, amend the engrossed bill as follows:

2 1. Page 148, line 2: decrease the dollar amount for fiscal year 2005-06 by  
3 \$38,000,000 for the purpose of reducing funding for preliminary work for the Zoo  
4 interchange-USH 45 reconstruction project.

5 2. Page 726, line 17: after that line insert:

6 "SECTION 1700m. 78.23 of the statutes is created to read:

7 78.23 Motor vehicle fuel tax holiday. ~~The sale of gasoline or diesel fuel in~~  
8 ~~this state~~ during the period beginning on July 1, 2006, and ending on September 4,  
9 2006, ~~is not subject to the taxes imposed under this subchapter.~~

the department shall reduce the rate of the tax imposed under s. 78.01 so that the total reduction in motor vehicle fuel tax receipts for that period is approximately \$38,000,000.
