

2005 ASSEMBLY BILL 102

1 **AN ACT *to repeal*** 20.003 (4) (f) of the statutes; **relating to:** decreasing an
2 appropriation of general purpose revenues for the Badger Care health care
3 program; increasing an appropriation of general purpose revenues for
4 prescription drug assistance; increasing an appropriation of general purpose
5 revenues for Medical Assistance; transferring moneys from the general fund to
6 the Medical Assistance trust fund; required general fund statutory balance;
7 and making an appropriation.

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

8 **SECTION 1.** 20.003 (4) (f) of the statutes is repealed.

9 **SECTION 9130. Nonstatutory provisions; legislature.**

1 (1) EXEMPTION FROM CERTAIN LEGISLATIVE RULES OF PROCEEDING. Section 20.003
2 (4m) of the statutes does not apply to the actions of the legislature in enacting this
3 act.

4 (2m) HO-CHUNK NATION INDIAN GAMING PAYMENTS. Notwithstanding section
5 569.06 of the statutes, all Indian gaming receipts, as defined in section 569.01 (1m)
6 of the statutes, received from the Ho-Chunk Nation in fiscal year 2004-05 shall be
7 deposited in the general fund.

8 **SECTION 9221. Appropriation changes; health and family services.**

9 (1) BADGER CARE HEALTH CARE PROGRAM. In the schedule under section 20.005
10 (3) of the statutes for the appropriation to the department of health and family
11 services under section 20.435 (4) (bc) of the statutes, as affected by the acts of 2005,
12 the dollar amount is decreased by \$9,500,000 for fiscal year 2004-05 to decrease
13 funding for the purpose for which the appropriation is made.

14 (2) PRESCRIPTION DRUG ASSISTANCE FOR ELDERLY. In the schedule under section
15 20.005 (3) of the statutes for the appropriation to the department of health and family
16 services under section 20.435 (4) (bv) of the statutes, as affected by the acts of 2005,
17 the dollar amount is increased by \$12,234,000 for fiscal year 2004-05 to increase
18 funding for the purpose for which the appropriation is made.

19 (3) MEDICAL ASSISTANCE. In the schedule under section 20.005 (3) of the statutes
20 for the appropriation to the department of health and family services under section
21 20.435 (4) (b) of the statutes, as affected by the acts of 2005, the dollar amount is
22 increased by \$69,800,000 for fiscal year 2004-05 to increase funding for the purposes
23 for which the appropriation is made.

24 (4) MEDICAL ASSISTANCE; MEDICAL ASSISTANCE TRUST FUND. Notwithstanding the
25 limitation under section 25.77 (intro.) of the statutes concerning content of the

1 Medical Assistance trust fund, there is transferred in fiscal year 2004–05 from the
2 general fund to the Medical Assistance trust fund \$50,000,000.

3 (5m) MEDICAL ASSISTANCE TRUST FUND; GENERAL FUND TRANSFER.

4 Notwithstanding the limitation under section 25.77 (intro.) of the statutes
5 concerning content of the Medical Assistance trust fund, there is transferred in fiscal
6 year 2004–05 from the general fund to the Medical Assistance trust fund the amount
7 of any moneys deposited into the general fund under SECTION 9130 (2m) of this act.
