At the locations indicated, amend the bill as follows:

1. Page 2, line 5: after that line insert:

- "(2) Ho-Chunk Nation Indian gaming receipts. Notwithstanding section 569.06 of the statutes, all Indian gaming receipts, as defined in section 569.01 (1m) of the statutes, received from the Ho-Chunk Nation in fiscal year 2004-05 shall be deposited in the general fund."
 - 2. Page 3, line 11: after that line insert:
- "(5) Medical Assistance trust fund; General fund transfer. Notwithstanding the limitation under section 25.77 (intro.) of the statutes concerning content of the Medical Assistance trust fund, there is transferred in fiscal year 2004–05 from the

general fund to the Medical Assistance trust fund the amount of any moneys deposited into the general fund under Section 9130 (2) of this act.".
