2 **1.** Page 2, line 5: after that line insert:

3 ^M“(2) HO-CHUNK NATION INDIAN GAMING PAYMENTS. Notwithstanding section
4 569.06[✓] of the statutes, all Indian gaming receipts, as defined in section[✓] 569.01 (1m)
5 of the statutes, received from the Ho-Chunk Nation in fiscal year[✓] 2004-05 shall be
6 deposited in the general fund.”[✓]

7 **2.** Page 3, line 11: after that line insert:

8 ^M“(5) MEDICAL ASSISTANCE TRUST FUND; GENERAL FUND TRANSFER. Notwithstanding
9 the limitation under section 25.77 (intro.)[✓] of the statutes concerning content of the
10 Medical Assistance trust fund, there is transferred in fiscal year 2004-05 from the

1 general fund to the Medical Assistance trust fund the amount of any moneys
2 deposited into the general fund under Section 9130 (2) of this act.”
