6 49.688 (3) (a) For each 12-month benefit period, a program enrollment fee of
7 \$30 \$20.

8 SECTION 1de. 49.688 (3) (b) 1. (intro.) of the statutes is renumbered 49.688 (3)

9 (b) 1. and amended to read:

10 49.688 (3) (b) 1. For each 12-month benefit period, for a person specified in sub.
11 (2) (a), a deductible for prescription drugs ~~that is based on the percentage that a~~
12 person's of \$500, except that a person whose annual household income, as

1 determined by the department, is 160% or less of the federal poverty line for a family
2 the size of the person's eligible family, ~~as follows:~~ shall pay no deductible.
