6 3. Page 23, line 7: delete "and the remaining" and substitute "the".

7 4. Page 23, line 8: delete "to 7." and substitute "and 6."

8 5. Page 23, line 9: after "2008" insert "; and the remaining initial members

9 appointed under section 15.157 (13) (a) 7. to 9. of the statutes, as created by this act,

10 shall be appointed for terms that expire on July 1, 2009".
