# *The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

4 **SECTION 1.** 29.183 of the statutes is created to read:

29.183 Deferral of certain approvals. (1) The department shall defer as
provided in sub. (4), upon request from a person who meets the requirements under
sub. (2) and who submits a request under sub. (3), any of the following approvals that
the department issues to the person under a random or preference selection system:
(a) Hunter's choice deer hunting permit.

2	(d) Otter trapping permit.
3	(e) Fisher trapping permit.

7	(i) Class A bear license.
8	(j) Elk hunting license.
9	(k) Sturgeon spearing license.
10	(2) A person shall meet all of the following requirements to be eligible for the
11	deferral of an approval under sub. (1):
12	(a) Be selected under a random or preference selection system for the issuance
13	of any of the approvals listed in sub. (1).
14	(b) Be serving on active duty in the U.S. armed forces or national guard.
15	(c) Be unable to exercise his or her privilege to fish, hunt, or trap as permitted
16	by that approval due to his or her service on active duty in the U. S. armed forces or
17	national guard.
18	(3) A person who meets the requirements under sub. (2) may request, or have
19	a request made on his or her behalf, that the department defer the person's approval.
20	(4) If the department receives a request for a deferral of an approval under sub.
21	(3) and any approval and tags that have already been issued before the day prior to
22	the beginning of that hunting or trapping season, the department shall defer the
23	person's approval.
24	(5) The department shall notify the person whose approval was deferred under
25	sub. (4) that he or she may receive that deferred approval after his or her active duty

1 ends without applying under the random or preference selection system. A person 2 whose approval was deferred under sub. (4) may apply for that approval during the 3 calendar year that the person ceased serving on active duty in the U.S. armed forces 4 or national guard, during the calendar year following the calendar year that the 5 person ceased serving on active duty in the U.S. armed forces or national guard, or 6 earlier if he or she is able to exercise his or her privilege to fish, hunt, or trap. Upon 7 receipt of the appropriate fees and the application form prescribed by the 8 department, the department shall issue the person his or her approval that was 9 deferred.
