Jeff and Loni,

We'd like to get two simple amendments drafted to AB 211.

#1: In Section 10, on page 6, lines 10-12, delete the amendment language and instead insert the following: Names, addresses, license numbers, and social security numbers obtained by the department under this subsection shall be provided to the department of revenue for the purpose of administering setoffs under ss. 71.93 and 71.935 and state taxes. [this language was provided by the department and is identical to that drafted in section 6 of AB 68]

#2: Create a new section to modify 71.93(5), using language similar to that in Section 5 on page 4, lines 24-25 and page 5 lines 1-6. The purpose of this amendment is to give DOR the ability to have a single method of administering this program, providing consistency in the method of charging other state agencies along with counties and municipalities.
