Drafting request for amendment to AB 211

Using AA 2 to AB 211 (LRB0423), draft a simple amendment to the original bill. [We will ask the committee to consider this new amendment instead of AA2. We will ask that AA2 not be taken up.]

Make the two following changes:

- 1. On lines 4 and 5, delete the words "At the time of each settlement,"
- 2. Add a new section in this amendment to amend the original bill, as follows:
  - 2. Page 4, line 24:
  - 71.935(5) At the time of each settlement, each Each

Rationale for the amendment: The phrase "At the time of each settlement," in (line 4) implies that DOR would charge the debtor for the admin fee on a quarterly basis (when settlement with the agencies and local governments occurs), while the sentence "The department may set off amounts charged to the debtor . . . against any refund owed to the debtor . . . " (lines 7 - 9) implies that the charge to the debtor would occur at the time of the setoff. DOR believes that the two statements appear to be contradictory and has suggested deleting the phrase "At the time of each settlement," from (5). This revision would be necessary in both 71.93 and 71.935.

**√ 1.** Page 4, line 13: after that line insert:

**"SECTION 3m.** 71.93 (5) of the statutes is amended to read:

71.93 (5) STATE AGENCY DEBTOR CHARGED FOR COSTS. At the time of each settlement, each state agency debtor shall be charged for administration expenses, and the amounts charged shall be credited to the department's appropriation under s. 20.566 (1) (h). The department may set off amounts charged to the debtor under this subsection against any refund owed to the debtor, in the manner provided in sub. (3). Annually on or before November 1, the department shall review its costs incurred during the previous fiscal year in administering state agency setoffs and shall adjust its subsequent charges to each state agency debtor to reflect that experience.".
