

This bill prohibits a facsimile solicitor who has received such notice from disclosing to another the facsimile transmission number of the person who gave the notice.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 134.72 (2) (c) of the statutes is created to read:
