### 2005 BILL

AN ACT to create 134.72 (2) (c) of the statutes; relating to: disclosure of facsimile 1 2

transmission numbers.

#### Analysis by the Legislative Reference Bureau

Current law prohibits a person from making a facsimile solicitation to a person who has given notice in writing or by facsimile that he or she does not want to receive facsimile transmissions. This bill prohibits a facsimile solicitor who has received such notice from disclosing to another the facsimile transmission number of the person who gave the notice.

#### The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 134.72 (2) (c) of the statutes is created to read:
- 134.72 (2) (c) A facsimile solicitor who receives notice under par. (b) may not 4 disclose to another the facsimile transmission number of the person who gave the 5 6 notice under par. (b).
  - SECTION 2. Effective date.
