1 AN ACT *to amend* 115.38 (2) of the statutes; **relating to:** school and school
2 district performance reports.

Analysis by the Legislative Reference Bureau

Under current law, each school board must by January 1 each year distribute to the parent or guardian of each pupil enrolled in the school district a copy of the school and school district performance report, which contains information such as scores on statewide pupil examinations and attendance and retention rates, as well as a comparison of the school district's performance with the performance of other school districts in the same athletic conference.

This bill requires instead that the school board send the report by May 1 each year only to parents or guardians who request it and, if the school district maintains an Internet site, requires the report be made available to the public at that site.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 115.38 (2) of the statutes is amended to read:
