Marc:

I talked to Bob Conlin at Leg Council.

He agreed with the conclusion that you and I reached.

The insertion could be as simple as "not exceeding 10 acres of property in any municipality".

He suggests that the phrase "in any municipality" would clarify that the limit is not to be applied on a statewide basis.

My recollection is that all exemptions are applied on a municipal by municipal basis, but I am not sure of the basis for that application.

It is probably better to be safe and retain those three words.

Once again, please draft this as a Senate amendment for the LFB.

JFC meets tomorrow at 10.
