"(3c) Mental Health and alcohol and drug abuse treatment benefit. The Health Insurance Risk-Sharing Plan Authority shall assess the historic utilization experience and diagnosis-related needs of the persons who are, and persons who have been, covered under the Health Insurance Risk-Sharing Plan to determine if the benefits under section 149.14 (3) (c) of the statutes, as affected by this act, for mental health and alcoholism and other drug abuse treatment provide for the use of evidence-based treatment standards and coverage levels sufficient to meet the

mental health and alcoholism and other drug abuse treatment needs of persons covered under the Health Insurance Risk-Sharing Plan. No later than December 2006, the Health Insurance Risk-Sharing Plan Authority shall submit a report of its findings to the appropriate standing committees of the legislature in the manner provided under section 13.172 (3) of the statutes and to the governor. On or after January 1, 2007, the Health Insurance Risk-Sharing Plan Authority shall make any necessary adjustments to the minimum required benefits under section 149.14 (3) (c) of the statutes, as affected by this act, to ensure that persons covered under the Health Insurance Risk-Sharing Plan have appropriate access to evidence-based mental health and alcoholism and other drug abuse treatment strategies and, if necessary, shall submit to the appropriate standing committees of the legislature in the manner provided under section 13.172 (3) of the statutes and to the governor any proposed changes to section 149.14 (3) (c) of the statutes, as affected by this act.".
