On or after January 1, 2007, the Health Insurance Risk—Sharing Plan Authority shall make any necessary adjustments to the minimum required benefits under section 149.14 (3) (c) of the statutes, as affected by this act, to ensure that persons covered under the Health Insurance Risk—Sharing Plan have appropriate access to evidence—based mental health and alcoholism and other drug abuse treatment strategies and, if necessary, shall submit to the appropriate standing committees of the legislature in the manner provided under section 13.172 (3) of the statutes and to the governor any proposed changes to section 149.14 (3) (c) of the statutes, as affected by this act.".
