February 3, 2005 – Introduced by Representatives Kestell, Suder, Gottlieb, GUNDERSON, HAHN, HINES, JESKEWITZ, F. LASEE, LEMAHIEU, MCCORMICK, MEYER, NASS, OTT, OWENS, PRIDEMORE, PETROWSKI, TOWNS, VAN ROY, VOS, VRAKAS, Vickmir and Ziegerbauer, cosponsored by Senators Grothman Cowles, Ellis, KANAVAS, A. LASEE, LAZICH, LEIBHAM and ROESSLER. Referred to Committee on Housing.

N  $\operatorname{ACT}$  to create 234.59 (3) (d) of the statutes, relating to: prohibiting the 1 2 Wisconsin Housing and Economic Development Authority from making, 3 buying, or assuming a home mortgage loan for an individual who does not have 4 a social security number.

# Analysis by the Legislative Reference Bureau

Under current kaw, the Wisconsin Housing and Economic Development Authority (WHEDA) makes and participates in making various types of loans for housing and economic development purposes, often for housing projects that benefit low-income, elderly or disabled persons. This bill provides that WHEDA may not make, buy, or assume a home mortgage loan for a person who does not have a valid social security number.

At the locations ndicated, amend the bill as follows:

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows: Page 9, line 3: after that the insert!

SECTION #. 234.59 (3) (d) of the statutes is created to read:

234.59 (3) (d) The authority may not make, buy, or assume a home ownership

mortgage loan for an individual who does not have a social security number.
