#, page 2, line 20 delete "2006" and substitute "2007" 1

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 5: delete "Before" and substitute "Before Except as provided

3 under s. 78.018, before".

4 **2.** Page 2, line 1: delete the material beginning with "After" and ending with

5 "(2)." on line 2.

6 **3.** Page 2, line 2: after that line insert:

7 "SECTION 1m. 78.018 of the statutes is created to read:

8 **78.018 Motor vehicle fuel tax holiday.** The tax imposed under s. 78.01 (1)

9 shall not be imposed during the period beginning on July 1, 2007, and ending on June

10 30, 2009."

11 **4.** Page 2, line 8: after that line insert:

12 "SECTION 3n. Nonstatutory provisions.

5 transportation fund if ~~the motor vehicle fuel tax holiday~~ had not been ⁱⁿ effect shall be
6 deposited into the transportation fund." *this act*
