lage 2°, line 60 delete "2006" and mbritishite "2007 &

At the locations indicated, amend the bill as follows:

1. Page 1, line 5: delete "Before" and substitute "Before Except as provided under s. 78.018, before".

- **2.** Page 2, line 1: delete the material beginning with "After" and ending with "(2)." on line 2.
 - **3.** Page 2, line 2: after that line insert:

"Section 1m. 78.018 of the statutes is created to read:

78.018 Motor vehicle fuel tax holiday. The tax imposed under s. 78.01 (1) shall not be imposed during the period beginning on July 1, 2007, and ending on June 30, 2009."

4. Page 2, line 8: after that line insert:

"Section 3n. Nonstatutory provisions.

ELIMINATION OF

INDEXING

(1) FUNDING FOR MOTOR VEHICLE FUEL TAX HOLDAY. On or before July 1, 2007,
the legislature shall provide by law a funding source for the motor vehicle fuel tax
holiday under section 78.018 of the statutes, as created by this act, so that an amount
equal to the amount of revenue that would have been deposited into the
transportation fund if the motor vehicle fuel tax holiday had not been effect shall be
deposited into the transportation fund.".
