4 84.01 (13) ENGINEERING SERVICES. The department may engage such  
5 engineering, consulting, surveying, or other specialized services as it deems  
6 advisable. ~~Any engagement of services under this subsection is exempt from ss.~~  
7 ~~16.70 to 16.7015, 16.71 to 16.75, 16.755 to 16.82, and 16.85 to 16.89, but ss. 16.528,~~  
8 ~~16.705, 16.752, and 16.754 apply to such engagement.~~ Any engagement involving  
9 an expenditure of \$3,000 or more shall be by formal contract approved by the  
10 governor."
