Hi Katie,

Sorry for the delay in getting back to you - I was out of the office.

As to the second item, s. 347.48 (2m) (c) [section 2 of the bill] generally addresses operator restrictions, and s. 347.48 (2m) (d) [section 3 of the bill] generally addresses passenger restrictions. The second item would seem to be a restriction on operation and would appear to be consistent with simply striking the language (as amended) "and not more than 16 years old" on p. 3, lines 7-8 of the bill. Is this what you want?
