

**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 2005 ASSEMBLY BILL 69**

May 17, 2005 – Offered by Representative KESSLER.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 3: after that line insert:

3 “**SECTION 1m.** 343.06 (1) (L) of the statutes, as created by 2005 Wisconsin Act  
4 .... (this act), is repealed.”.

5 **2.** Page 2, line 15: after that line insert:

6 “**SECTION 2m.** 343.14 (2) (er) of the statutes, as created by 2005 Wisconsin Act  
7 .... (this act), is repealed.”.

8 **3.** Page 2, line 18: after that line insert:

9 “**SECTION 3m.** 343.17 (3) (a) 14. of the statutes, as created by 2005 Wisconsin  
10 Act .... (this act), is repealed.”.

11 **4.** Page 3, line 3: after that line insert:

1           “**SECTION 4m.** 343.20 (1) (f) of the statutes, as created by 2005 Wisconsin Act  
2 .... (this act), is repealed.”.

3           **5.** Page 3, line 10: after that line insert:

4           “**SECTION 5m.** 343.20 (1m) of the statutes, as created by 2005 Wisconsin Act ....  
5 (this act), is repealed.”.

6           **6.** Page 3, line 19: after that line insert:

7           “**SECTION 6m.** 343.50 (4) of the statutes, as affected by 2005 Wisconsin Act ....  
8 (this act), is amended to read:

9           343.50 (4) APPLICATION. The application for an identification card shall include  
10 any information required under ss. 85.103 (2) and 343.14 (2) (a), (b), (bm), (br), and  
11 (em), ~~and (er)~~, and such further information as the department may reasonably  
12 require to enable it to determine whether the applicant is entitled by law to an  
13 identification card. The department shall, as part of the application process, take a  
14 photograph of the applicant to comply with sub. (3). No application may be processed  
15 without the photograph being taken. Misrepresentations in violation of s. 343.14 (5)  
16 are punishable as provided in s. 343.14 (9).”.

17           **7.** Page 4, line 6: after that line insert:

18           “**SECTION 7m.** 343.50 (5) of the statutes, as affected by 2005 Wisconsin Act ....  
19 (this act), is amended to read:

20           343.50 (5) VALID PERIOD; FEES. The fee for an original card and for the  
21 reinstatement of an identification card after cancellation under sub. (10) shall be \$9.  
22 The card shall be valid for the succeeding period of 4 years from the applicant’s next  
23 birthday after the date of issuance, ~~except that a card that is issued to a person who~~  
24 ~~is not a United States citizen and who provides documentary proof of legal status as~~

1 ~~provided under s. 343.14 (2) (er) shall expire on the date that the person's legal~~  
2 ~~presence in the United States is no longer authorized. If the documentary proof as~~  
3 ~~provided under s. 343.14 (2) (er) does not state the date that the person's legal~~  
4 ~~presence in the United States is no longer authorized, then the card shall be valid~~  
5 ~~for the succeeding period of 4 years from the applicant's next birthday after the date~~  
6 ~~of issuance."~~

7 **8.** Page 4, line 20: after that line insert:

8 "SECTION 8m. 343.50 (6) of the statutes, as affected by 2005 Wisconsin Act ....  
9 (this act), is amended to read:

10 343.50 (6) RENEWAL. At least 30 days prior to the expiration of the card, the  
11 department shall mail a renewal application to the last-known address of each  
12 identification card holder. The department shall include with the application  
13 information, as developed by all organ procurement organizations in cooperation  
14 with the department, that promotes anatomical donations and which relates to the  
15 anatomical donation opportunity available under s. 343.175. The fee for a renewal  
16 identification card shall be \$9, which card shall be valid for 4 years, ~~except that a card~~  
17 ~~that is issued to a person who is not a United States citizen and who provides~~  
18 ~~documentary proof of legal status as provided under s. 343.14 (2) (er) shall expire on~~  
19 ~~the date that the person's legal presence in the United States is no longer authorized.~~  
20 ~~If the documentary proof as provided under s. 343.14 (2) (er) does not state the date~~  
21 ~~that the person's legal presence in the United States is no longer authorized, then~~  
22 ~~the card shall be valid for 4 years."~~
