9 a driver's license. A driver's license issued under this section is valid for the purpose
10 of authorizing the holder to operate a motor vehicle upon a highway in this state.
11 Except as provided in s. 343.1055, a limited purpose driver's license shall not be valid
12 authorization for the operation of commercial motor vehicles. A limited purpose
13 driver's license shall be a different color or design from a regular license and shall
14 indicate on its face that the license may not be accepted by any federal agency for
