I spoke with Louis on Friday and mentioned that we need to make an amendment to AB 536.

On page 3 ... Letter **(e)** needs to be added.

A statement like this needs to follow..... **(1m) paragraphs (a) to (c) do not apply to chapter 69 subchapter 1.**

The State of Wisconsin Department of Health and Family Services vitals records division had their legal council look over this bill. Apparently this bill does cross reference to Chapter 69....even though this was not our intention. Our intention was for this bill to effect recorded documents not filed. Unfortunately recorded and filed is never defined in the state statutes either. This should be a quick easy amendment that will clarify things and make everyone happy.
