Possible Amendment Language for AB 29

Nonstatutory provisions.

(1) Notwithstanding section 16.42 (1) (e) of the statutes, in submitting information under section 16.42 of the statutes for purposes of the 2007-09 biennial budget bill, the department of transportation shall submit a dollar amount for the appropriation under section 20.395 (5) (cq) of the statutes that is \$11,900 less than the total amount appropriated under section 20.395 (5) (cq) of the statutes for the 2006-07 fiscal year, before submitting any information relating to any increase or decrease in the dollar amount for that appropriation for the 2007-09 fiscal biennium.

Appropriation changes.

(1) In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of transportation under section 20.395 (5) (cq) of the statutes, as affected by the acts of 2005, the dollar amount is increased by \$11,900 for fiscal year 2006-07 to increase funding for administering the buyer license card.
