

TO 2005 ASSEMBLY BILL 1024
SB 623 ✓

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 “**SECTION 1d.** 100.53 (1) (a) of the statutes, as created by 2005 Wisconsin Act
4 25, is renumbered 100.53 (1) (am).

5 **SECTION 1L.** 100.53 (1) (ag) of the statutes is created to read:

6 100.53 (1) (ag) “Government fee” means any fee charged by a rental company
7 to recover the cost of any fee or charge that is imposed by a government, airport or
8 other transportation authority, or any other government agent that is deemed
9 applicable to the rental of private vehicles in this state.

10 **SECTION 1p.** 100.53 (2) (a) of the statutes, as created by 2005 Wisconsin Act 25,
11 is amended to read:

12 100.53 (2) (a) The statement of the rental rate includes the amount of any title
13 or registration fee or government fee charged by the rental company.
