At the locations indicated, amend the bill as follows:

- 1. Page 1, line 4: after "cases" insert "and granting rule-making authority".
- 2. Page 5, line 23: delete the material beginning with that line and ending with page 6, line 2, and substitute:

"893.55 (4) (d) 2. The commissioner of insurance shall by rule increase the limits on noneconomic damages established under subd. 1. as often and by such amounts as the board of governors created under s. 619.04 (3) determines is necessary to meet the intent of the legislative findings under sub. (1d). The board of governors shall indicate, and the rule shall include, the reasons why the increase is necessary to meet the intent of those legislative findings.".
