"Section 9m. Nonstatutory provisions.

- BLUE RIBBON TASK FORCE ON MEDICAL MALPRACTICE INSURANCE. commissioner of insurance shall appoint a committee, to be known as the Blue Ribbon Task Force on Medical Malpractice Insurance, to study and advise the 9 commissioner on measures for controlling the cost of health care liability insurance.
