TO 2005 ASSEMBLY BILL 1073

NOW

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: after "cases" insert "and the creation of a committee to advise
3 on medical malpractice insurance cost control measures".

4 **2.** Page 6, line 2: after that line insert:

5 **"SECTION 9m. Nonstatutory provisions.**

6 (1) BLUE RIBBON TASK FORCE ON MEDICAL MALPRACTICE INSURANCE. The
7 commissioner of insurance shall appoint a committee, to be known as the "Blue
8 Ribbon Task Force on Medical Malpractice Insurance," to study and advise the
9 commissioner on measures for controlling the cost of health care liability insurance.

10 The committee shall be composed of the following members:

11 (a) Two physicians.

12 (b) Two representatives of insurance companies.

1 (c) Two members of the legislature.

2 (d) Two individuals who have received health care and who represent the
3 interest of health care recipients.

4 (e) One employee of the ~~Office of the~~ ~~Commissioner of~~ ~~Insurance.~~”.
