

1 At the locations indicated, amend the bill as follows:

2 1. Page 5, line 24: after "(2)" insert "and to the members of the joint committee
3 on finance".

4 2. Page 6, line 2: after "(1d)." insert "If the board of governors recommends any
5 change in the limit on noneconomic damages, the cochairpersons of the joint
6 committee on finance shall convene a meeting no later than 95 days after receiving
7 the report ~~to have the committee approve or disapprove the report's~~
8 ~~recommendations and introduce any legislation necessary to implement the~~
9 ~~committee's decision.~~".
