ASSEMBLY AMENDMENT,  
TO 2005 ASSEMBLY BILL 566

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 11: delete lines 11 to 16 and substitute:

3 "350.095 (1) (a) ~~Every snowmobile manufactured after July 1, 1972, and offered~~  
4 ~~for sale or sold in this state shall be so constructed as to limit total vehicle noise to~~  
5 ~~not more than 82 decibels of A sound pressure at 50 feet, as measured by society of~~  
6 ~~automotive engineers standards. Every snowmobile that is manufactured on or after~~  
7 July 1 2, 1975, and that".

8 2. Page 3, line 1: substitute "(b)" for "(c)".
