**Assumptions Used in Arriving at Fiscal Estimate**

It is a current practice at the Department of Workforce Development to share information with the Department of Public Instruction and other state agencies on transition and other vocational issues.

The Department already links the Division of Vocational Rehabilitation's web site to other vocational and work topics.

Therefore, there will be no additional fiscal cost for the Department to create links to a clearinghouse web site developed by the Department of Public Instruction, as well as add that link to DVR's web page.
